## **Findings of Fact, Conclusions**

## Of Law, and Final Order

This cause was presented before the Code Enforcement Board on March 03,2020, after due notice to the Respondent, and the Board having heard testimony, received evidence, heard and considered arguments, now issue its Findings of Fact, Conclusions of Law and Final Order, as follows:

## **Findings of Fact**

The Respondent, Jerry woody Slusher, whose mailing address is 1003 Exeter Avenue, Middlesboro, Ky 40965, is the owner or person in charge of property located at 1003 Exeter Avenue, Middlesboro, Kentucky 40965.

The Respondent received a citation issued by John O'Boyle, dated March 03,2020, which charged the Respondent with a violation of Section(s) 151.14, 91.01(B) of the Code of Ordinances of the City of Middlesboro, Kentucky described as follows: Every wall, window, door, floor, roof, and porch shall be maintained in sound condition and repair. Accumulation of trash, rubbish, garbage, and other waste materials is considered a nuisance.

The Board finds, based on all of the testimony and evidence presented at the hearing, that the condition described in the citation did, in fact, exist at the time the citation was issued, that the condition did constitute a violation of Section(s) 151.14, 91.01(B) of the Code of Ordinances of the City of Middlesboro, Kentucky, and that the condition was caused by, or was the responsibility of, the Respondent as owner, or person in charge, of the property on which the violation occurred.

The next Code Enforcement Board meeting is May 12, 2020 at 1:00 P.M. in Council Chambers at Middlesboro City Hall.

#### Conclusions of Law

The Board concludes, based on the foregoing Findings of Fact, the Respondent, Jerry Woody Slusher, has committed a violation of Section(s) 151.14, 91.01(B) of the Code of Ordinances of the City of Middlesboro, Kentucky, as charged in the citation.

#### **Final Order**

Respondent, Jerry Woody Slusher, is hereby ordered to correct the violation(s) on or before 30 days from date of issue of Final Order. In the event that the violation(s) is not corrected on or before the date specified, then there shall be imposed against the Respondent a civil fine of \$110 per month from date of Final Order, and continuing each day, up to the maximum allowable fine for this offense, until the violation is corrected. The burden shall rest upon the Respondent to request a re-inspection by the Code Enforcement Officer to determine whether the property is brought into compliance.

If Jerry Woody Slusher fails to comply within the time specified, a certified copy of this order, together with a Claim of Lien, shall be recorded in the Office of the County Clerk, and once recorded, along with all charges and fees incurred by the City in connection with enforcement, shall constitute a lien against the property upon which the violation exists, pursuant to KRS 65.8835. Pursuant to Chapter 151 of the Code of Ordinances of the City of Middlesboro, enforcement may be ordered, including demolition, as deemed necessary by the Code Enforcement Board. This lien may be foreclosed and the property sold to enforce the civil fine and all enforcement costs incurred by the City in connection with this matter.

Under KRS 65.8831, any final order issued by the Code Enforcement Board may be appealed to Bell County District Court. The appeal must be filed not later than thirty (30) from the date the Code Enforcement Board issues the final order.
